2018 Summer

At this past summer meeting, Dr. Daniel Becker, a repeat FAP clinician, presented the well-attended "Procedural Sedation in Dental Practice – Essential Principles Revisited" on Friday. On Saturday, Dr. Barry Levin, sponsored by **Dentsply Sirona** spoke on achieving predictable stability with esthetic dental implant therapy.

Business Meeting Highlights (August 11, 2018): FAP Member and FDA President, Dr. Jolene Paramore, spoke on CODA and recognized the FAP membership for sending numerous letters on this issue. She briefly spoke on Medicare and the opioid course requirement. Dental therapists, though defeated last year, will be back and the FDA will stand firm. She thanked all those who testified on behalf of the profession during BOD meetings.

Dr. Paramore shared that on the Florida Dental Association's Board of Trustees, 20% of BOT members are periodontists and on the FDA's delegation to the ADA, 14% are periodontists.

Dr. Jim Antoon, FAP Past President, and now serving as FLA-MOM Co-Chair, spoke on the upcoming 2019 Florida Mission of Mercy (FLA-MOM) in Orlando, March 22nd and 23rd. He asked members to volunteer, donate, and to bring their dental team members.

Dr. James Wilson, AAP Secretary-Treasurer (now V.P.) recognized Dr. Jim Antoon and shared he was the FDA's 2018 J. Leon Schwartz Award this year. Dr. Wilson said the best evidence consensus on lasers has just been released. He spoke on the proposed AAP


Perio PAC – Dr. Johnson reported the PAC has over \$32,000.00 and encouraged everyone to donate.

Required Course

As required by the Legislature under Section 456.0201, Florida Statutes, each prescribing practitioner who is registered with the United States Drug Enforcement Administration is required to take a board approved continuing education (CE/CME) course (unless the practitioner is already required to complete such a course under his or her practice act)

The following practitioners must complete the CE/CME course by January 31, 2019, if they have a DEA number. The chart below indicates when you must complete the CE/CME course for the first two times. After that, you will need to complete the course during each subsequent renewal period.

Go to www.cebroker.com to search for your profession's board-approved courses.

Profession	Required Course Completion Date
Allopathic Physician (Group 2)	Course must be completed by January 31, 2019 and again by January 31, 2021.
Certified Optometrist	Course must be completed by January 31, 2019 and again by February 28, 2021.
Allopathic Physician (Group T)	Course must be completed by January 31, 2019 and again by January 31, 2022
Dentist	Course must be completed by January 31, 2019 and again by February 28, 2022.
Osteopathic Physician	Course must be completed by January 31, 2019 and again by March 31, 2022
Podiatrist	Course must be completed by January 31, 2019 and again by March 31, 2022.
