### NOVA SOUTHEASTERN UNIVERSITY



The inability to control the patient's airway and ventilations is one of the greatest killers in the emergency setting. 

# Florida Board of Dentistry Report

The BOD held a Sedation Inspection Workshop on February 14, 2019. The workshop was open to all permit holders and those applying for a permit. The inspection process was reviewed for both initial and routine inspections. At the end of the workshop the idea to move the inspection process to the DOH bureau of enforcement was introduced.

The Florida Board of Dentistry (BOD) met in Gainesville on Friday, February 15, 2019:

**Review of Applications** – An applicant for a pediatric sedation permit withdrew her application as the BOD advised her that she needed to take a course in pediatric sedation in order to qualify to apply for a pediatric sedation permit. The BOD was not going to allow her to use a conscious sedation course (that did not focus on pediatric patients) to qualify for a pediatric sedation permit.

**Chair Report** - Dr. Miro asked the BOD to reconsider its revision to Rule 64B5-15.018 at its last meeting where it increased the fee for an initial anesthesia permit to \$2000. The BOD voted to withdraw this rule and the fee is now again \$300.

**Commission on Dental Competency Assessments (CDCA) Report** - Dr. Dennis from the CDCA requested the BOD develop a closer relationship with the CDCA. All BOD members are invited to attend their annual meeting and it is a good opportunity for BOD members to caucus with examiners from Florida and other parts of the country.

**Council on Dental Hygiene** - The BOD approved the following modification to Rule 64B5-16.001 Definitions of Remediable Tasks and Supervision Levels. Current rule allows a hygienist to use an assessment device. This rule is clarifying that a hygienist can use a diagnodent. The BOD approved the following modification to ownership of dental instruments by a dental hygienist - a note of clarification was put on the record that the only instruments that a hygienist could own under this rule would be the tools they can use under their scope of practice.

**Legislation Update** - The BOD heard testimony from Dr. Frank Catalanotto and the Florida Dental Hygiene Association in support of Dental Therapy. The BOD cannot lobby or influence this legislation. Board members asked questions and challenged Dr. Catalanotto on some of his main points.

## Update on Dental Therapy

Legislation was filed this session to authorize dental therapists in Florida. The FDA was successful in stopping both House and Senate bills in their first committee. Neither bill (SB 684 by Sen. Jeff Brandes and HB 649 by Rep. Rene Plasencia) are expected to be addressed again this year.
