Dr. Kenneth Kornman – The New Classification of Periodontitis: Why Are We Changing, and How Do I Get Started with the New Classification? 10:00am-12:00pm – 2 CEUs



The future of periodontics is primarily about managing clinically and biologically complex patients, which constitute at least 20 to 25% of our adult population. Based on knowledge at the time of the 1999 World Workshop on Classification of Periodontal Diseases, experts in the field described an approach for classifying periodontitis based almost entirely on past severity of disease. In the two decades since the 1999 Workshop, substantial new evidence and new understandings of these diseases have emerged that indicate some of the population develops more severe clinical expression of periodontitis. Evidence supports an interaction of multiple risk factors that translates periodontitis in some of our patients into severe disease with greater complexity of clinical management.

The new periodontitis classification acknowledges the importance of more than disease severity to best guide prevention and treatment of periodontal disease in our patients. Achievement of long-term oral and systemic health outcomes in the complex cases require specialtylevel diagnostic and surgical skills, informed by deep knowledge and concepts defined in the 2018 reclassification of periodontitis and the new classification of peri-implant diseases and conditions.

This presentation will describe the rationale for why our periodontitis classification system needed to change, and how to identify patients who present with complex cases. By definition, each complex case must be defined at the individual patient level, and the treatment planning inherently involves precision management of the individual patient. Importantly, the new periodontics should define a new role for the periodontist in the dental and medical care systems of today and the future.

#### FAP FISCAL YEAR 2021 BUDGET

RECOMMENDATION: The following resolution is submitted for the voting members of the Florida Academy of Periodontists (FAP) consideration:

BE IT RESOLVED, that the Florida Academy of Periodontist's (FAP) Fiscal Year 2020 budget as amended, is hereby adopted. And, be it further

RESOLVED, that the FAP membership 2021 calendar-year dues for full-dues paying members be increased \$55.00 from the \$195.00 current 2020 calendar-year dues level.

RESOLVED, Dues will be \$250.00 starting in 2021

BACKGROUND:

Since 2010, the Florida Association of Periodontists has not increased their membership dues. Unfortunately, venue costs; food, beverage and audio-visual, continue to rise. The FAP does not charge its active members a meeting registration fee for its two-yearly meetings.

The Florida Association of Periodontists Executive Council had ample discussion on the topic and in order to stay financially healthy a \$55 increase is recommended.

The FAP dues increase budget for next fiscal year (FY 2021) needs to be approved by eligible voting members of FAP present at the February 8, 2020 business meeting, held in conjunction with the FAP Winter Meeting, February 7-8, 2020, Disney Dolphin Resort.

According to FAP Bylaws:

#### CHAPTER V FEES, DUES AND FISCAL MATTERS

Section 1 Fees and Dues

(a) Active Members

The initiation fee shall be \$50.00. The annual dues shall be determined by the Executive Council and voted on by the General Membership.

#### FAP Bylaws Change:

RECOMMENDATION: The following resolution is submitted for the voting members of the Florida Academy of Periodontist's (FAP) consideration:

BE IT RESOLVED, that the Florida Academy of Periodontist's (FAP) Treasurer no longer serves as a line officer. And, be it further

RESOLVED, the FAP Treasurer will be a separate executive council member for a three-year term with a limit of two terms. And, be it further

RESOLVED, that at the end of the term, the FAP Treasurer has the option to pursue or not the FAP officer line as First Member at Large.

#### BACKGROUND:

Within an organization, the continuity of certain positions provides vision, strength, and further wisdom that may aide the growth of the organization by being able to foresee and resolve upcoming issues. The Treasurer is a valuable position that may provide continuity, strength, and vision.

The current FAP Bylaws does not allow an appointed volunteer member to maintain the Treasurer position for more than one year. During this year, this appointed volunteer must learn how to manage and aide on the budget preparation, get acquainted with the FAP Financial institutions, and be able to provide reports for our Executive council meetings and 2-yearly membership venues.

The Florida Association of Periodontists Executive Council has proposed that the Florida Association of Periodontists Treasurer; in order to assist with ease of administrative duties and to assure consistency in overseeing the crucial and responsible position of Treasurer, serves a three-year term, with a limit of two terms. Upon completion of the term or terms, the Treasurer has the option of electing to become a line officer by entering the Florida Association of Periodontists Executive line as First Member at Large, with the approval of the Florida Association of Periodontists Executive Council and a final approval by the members of the Florida Association of Periodontists.

The By-Laws change needs to be approved by eligible voting members of Florida Association of Periodontists present at the February 8, 2020 business meeting, held in conjunction with the FAP Winter Meeting, February 7-8, 2020, Disney Dolphin Resort.

#### ARTICLE V - MANAGEMENT

The affairs of the Association shall be managed by a Board of Directors to be known as the Executive Council and composed of the President, President Elect, Secretary/<del>Treasurer</del>, Immediate Past President, <del>and</del> two Membersat-Large, <u>and Treasurer</u>, all <u>elected approved</u> by and from the membership. The Officers and Members at Large shall be <u>elected approved</u> at the annual meeting of the membership.

#### CHAPTER III EXECUTIVE COUNCIL

Section 1 Name and Composition

The administrative body of this Association shall be the Executive Council which shall be composed of the President, President Elect, Secretary, /<del>Treasurer</del>, Immediate Past President, <del>and</del> two Members at Large, and <u>Treasurer</u>, all <del>elected</del> <u>approved</u> by and from the membership. The Officers and Members at Large shall be <del>elected</del> <u>approved</u> at the first business meeting of the calendar year.

Section 2 Term of Office

The Officers of this Association serving on the Executive Council shall serve in such capacity as long as they hold their respective offices in the Association. The elected members shall serve for a term of one year. No elected members shall serve two consecutive terms, with the exception of the FAP Treasurer that will be a separate executive council member for a three-year term with a limit of two terms that at the end of the term, the FAP Treasurer has the option to pursue, or not, the FAP officer line as First. Member at Large with the approval of the FAP Executive Council and final approval by FAP membership.

#### CHAPTER IV ELECTIVE OFFICERS

Section 1 Name and Number

The elective officers of this Association shall be a President, a President Elect, a Secretary<del>/Treasurer</del>, a First Member at Large, a Second Member-at-Large, <del>and</del> an Immediate Past President, <u>and a</u> <u>Treasurer</u>.

Section 2 Term of Office

All <u>elective</u> officers shall hold office from the Annual Meeting at which they were elected until the following Annual Meeting when their successors are duly elected and installed. <u>The Treasurer shall</u> <u>serve a three-year term, limited to two terms.</u>

#### Section 3 Nomination and Election

Elective officers shall be nominated by the Executive Council or from the floor by any member. The Executive Council shall encourage the membership to consider geographical rotation when nominating members for elective office. Elections will be conducted during the first business meeting of the calendar year. <u>The Treasurer shall be appointed by the Executive Council and</u> <u>approved by membership</u>.

Section 5 Duties

#### (c) Secretary<del>/Treasurer</del>:

The Secretary<del>/Treasurer</del> shall maintain accurate records of all meetings of the Association and the Executive Council and preserve the Minutes of such meetings with assistance from the Executive Director. He/She shall serve as custodian of all monies and financialassets of the Association and shall hold, invest, or disburse samesubject to the direction of the Executive Council. He/She <u>The</u> <u>Secretary</u> shall perform such other duties as are assigned by these Bylaws, the Executive Council, or Membership.

d) Treasurer:

The Treasurer shall, with the assistance of the Executive Director,

 deposit all funds due this Association in banking institutions, or institutions approved by the Executive Council;
 be accountable to the Executive Council and to the Association, and at such times as ordered, give an accounting to either body
 sign all checks in order to pay all approved bills;
 remit all records, forms and physical assets of this association to a successor within thirty (30) days following the installation of a successor;
 be a non-voting member of the Executive Council;

## 2020 Winter Meeting Speaker Bios

#### Dr. Alfonso Piñeyro

Dr. Alfonso Piñeyro received his dental degree from the Universidad Autonoma de Guadalajara. He then completed a two-year advanced education in general dentistry before completing his specialist training in prosthodontics at the University of Rochester Eastman Dental Center.

He is currently an affiliate instructor at the Department of Restorative Dentistry at the University of Washington. He is a past president of the esteemed Washington State Society of Prosthodontists and is also a member of the American College of Prosthodontists and the American Prosthodontics Society.

Dr. Piñeyro has authored several publications in peer reviewed dental journals and chapters in textbooks. He is currently involved

in research focusing on dental implants and has developed a set of unique instruments used for implant hygiene and maintenance. Dr. Piñeyro practices full time in the Seattle, Washington area, in a practice limited to fixed implant prosthodontics.

He has lectured both nationally and internationally and has presented over 300 lectures for multiple dental study clubs and dental associations. He has been invited to speak to large national dental symposiums which include: Seattle Study Club Symposium, American Academy of Periodontology, American Academy of Implant Dentistry, American Academy of Fixed Prosthodontics, Academy of Osseointegration, American College of Prosthodontists, Academy of LDS Dentists, and The 12th International Symposium on Periodontics and Restorative Dentistry.

#### Dr. Kenneth Kornman

Dr. Kenneth Kornman is an Adjunct Professor in the Department of Periodontics and Oral Medicine at the University of Michigan School of Dentistry, Editor of the Journal of Periodontology, and a member of the management team of SITOKINE Ltd, a London based genetics company focused on prevention of major cardiovascular disease events and certain types of cancer.

He was previously the Chairman of Periodontics and Professor of Microbiology at University of Texas Health Science Center at San Antonio. His research focuses on genetics of chronic inflammatory diseases as it relates to predisposition and treatment. He has published more than 150 original manuscripts, including papers in Science, The New England Journal of Medicine, Journal of the American College of Cardiology, Human Molecular Genetics, and numerous papers in the periodontal journals.

Dr. Kornman, together with Maurizio Tonetti and Henry Greenwell, authored the World Workshop paper on classification of periodontitis published in Journal of Periodontology 2018.
