## COURSE DESCRIPTIONS:

### Friday, August 13, 2021

Shaun Fix, President - Emergency Medical Consultants, Inc.  
4 CEUs – 12:30pm-5:00pm  
**Airway Management Course**

The course will provide didactic, video, and case-based hands-on skills labs dealing with medical and airway emergencies possible in the dental and sedation settings.

Participants will review, practice, and demonstrate proficiency in managing emergencies including but not limited to respiratory distress and failure, using bag mask, oral and nasal airways, perilaryngeal devices, as well as intubation and cricothyrotomy. Recognizing and treating emergencies such as cardiac events, stroke, syncope, seizures, allergic reactions and laryngospasm will be reviewed and practiced.

### Saturday, August 14, 2021

Dr. Dennis Tarnow – 5 CEUs – 9am-4pm

Morning Lecture: **Immediate Extraction Socket Management in the Esthetic Zone and Molars - *What we know, what we think we know, and what we don't know about.***

Immediate placements of implants into extraction sockets is an exciting treatment alternative for our patients. However, there are many potential short and particularly long-term risks which the practitioner must be fully aware of. This presentation will focus on the potential problems and benefits both clinically and biologically when the choice of immediate socket placement is made for single and multiple sites. This will be an evidence-based presentation that will be objective about the best and simplest way to treat these types of cases.



Upon completion of this presentation participants should be able to:

- Identify what type of healing takes place against the implant in immediate socket placement
- Know how to minimize recession with immediate provisionalization
- Know the proper crown contour for immediate provisionals
- Know if the gap distance really matters
- Know if primary closure should be attempted or should it be left open?

## Course Descriptions (cont'd)

- Know if membranes should be utilized?
- Know what type of graft material if any should be utilized?
- Identify what are the potential short and long term risks involved with immediate placement of implants

### Afternoon Lecture: **Interdisciplinary Management of Aesthetic Problem Cases**

The treatment planning of complex cases requires the highest level of knowledge and skill of the treating team. It is an orchestration of procedures including proper sequencing and timing that makes the difference. An envisionment of the final case before starting is required to know where the goal of treatment will be directed. This, in conjunction with the patient's needs and clinical situation comprise the decision-making process for what is the best treatment for the patient.

Problems facing the team such as:

- Which teeth to save or extract?
- Should implants be placed immediately or in a delayed protocol?
- Should multiple implants be placed in the aesthetic zone?
- When and how to include orthodontics if needed for sight development
- Should pink ceramic be used or should ridge augmentation be performed?
- Should the case be splinted or broken up into separate bridges or individual teeth?
- How to provisionalize the case throughout treatment
- When to immediate load cases versus do a serial extraction case

These concerns will be addressed in this interdisciplinary approach to our most challenging cases.

# The FAP and 60 Years of Meeting Excellence

This year marks the 60<sup>th</sup> Anniversary of the Florida Association of Periodontists. As the FAP celebrates 60 years of association and meeting excellence, we ask FAP members reach out to their peers, invite them to join and invite them to a meeting!

The following was printed in the Winter 2020 Newsletter. Since the actual anniversary date is closer, the history of this fine organization deserves a reprint.

On May 23, 1961, sixteen dentists, with dental practices limited to periodontics, met in Miami Beach, Florida. A preliminary discussion was held with each giving their ideas as to the advisability of organizing and to the aims and purposes of such an organization. The Florida Society of Periodontists was formed that day and Dr. Richard Chace was elected to serve as the first President (Chairman).

The charter members were: Drs. Frank Scott, Harold Pattishall, Norman Becker, Ray Spyrès, Art Green, Mavin Rosenberg, Morthon Rosenbluth, Blair Madsen, Jack Whitman, Richard Chace, Clinton Rehnke, Ken Langley, James Tobias, Jack Mishkin, Charles Hall and Hal Rhea.

The next meeting of these esteemed professionals was held in Orlando where the constitution and by-laws were adopted. Also, each member there was asked to present a case for group discussion as part of the program. The feeling among those present was the meeting should be a place for study and discussion of mutual problems, not for social activities.

Today, the Florida Association of Periodontists (FAP) has over 280 members and has two continuing education meetings each year, the winter meeting in February and the summer meeting in August. The meetings are usually held in Tampa or Orlando and are supported by various exhibitors and sponsors.

The FAP Executive Council consists of seven officers. They meet in conjunction with the two general meetings and throughout the year via conference call. This is a select group chosen by FAP membership and many of them serve in different capacities in organized dentistry, dental study clubs, and within academia.

FAP members are represented at the national level (American Academy of Periodontology) by elected trustees. The FAP proudly has two members serving in this capacity as District III Trustees, Drs. John Russo and Cecil White, Jr. FAP Member and Past President, Dr. James Wilson is currently serving as AAP President.

The Florida Association of Periodontists continues to grow and is active within state and national issues involving the laws and rules of dentistry and the overall well-being of patients.

# 2021 FAP Business Meeting - March 4, 2021 – Minutes

Due to the cancellation of the 2021 Winter Meeting, the FAP Executive Council held the FAP General Business Meeting via Zoom. Thank you to all the FAP members who signed on to assist in establishing a quorum. Thank you Dr. Jessica Stilley Mallah for a job well done during a challenging year. The President's Plaque and Pin presentations will be during the Summer Meeting General Business Meeting. The following are the minutes from the meeting:

## **Dr. Jessica Stilley Mallah, President, Presiding**

### Call to Order

Dr. Stilley called the meeting to order at 6:34 p.m.

### Welcome and Introduction of Guests

Dr. Stilley Mallah welcomed everyone to the meeting and introduced Dr. Nicholas Caplanis and Dr. Mia Geisinger, candidates for AAP Secretary.

Dr. Caplanis and then, Dr. Geisinger, addressed the group explaining why they were running for AAP Secretary.

Additional Agenda Items There were none.

### Approval of Minutes (February 8, 2020)

Motion was made to approve the minutes. Seconded. **Motion adopted unanimously.**

### Reports

Treasurer's Report - Dr. Oscar Morejon, FAP Treasurer, reported the FAP is financially sound and the Morgan Stanley investment account is doing well.

### Florida Board of Dentistry

Dr. Susan LaMar reported the Florida BOD met virtually on February 19, 2021. The BOD recognized two new BOD members, both periodontists, Dr. Thomas McCawley (term will end 10/31/2022) and Dr. Jose Mellado (term will end 10/31/2024). Dr. LaMar went through some of the disciplinary proceedings and the workshop that will be scheduled for public comment and testimony regarding use of lasers by registered dental hygienists. There was a legislative update which included the Senate bill reintroduced on dental therapist and House bill allowing ADEX (American Board of Dental Examiners) or WREB (Western Regional Examining Board) exam for licensure. The Anesthesia Committee reported 405 inspections were performed in 2020 and expect 600 in 2021. The next BOD meeting is May 21, 2021 in Orlando, if the BOD meets in person.

### Membership Report

Dr. LaMar presented the membership report. As of February, the FAP has 300 total members. The FAP Executive Council considered and voted in the following new members: **Drs. Stuart Beauchamp, Fabrianne Figueroa Cohen, and Kristian Poventud.** The EC also approved Dr. Edward Baines for Lifetime Membership. Dr. LaMar gave memoriam to FAP Past President, Dr. Robert T. Ferris and recognized a few of his outstanding achievements. Dr. Ferris passed away October 1, 2020.

### New Business

AAP's State Regional Assembly – Dr. Stilley Mallah announced the FAP is looking for someone to fill this position. She has done it for several years, but the time has come to turn the position over to someone else.

### Nomination of First Member at Large and Presentation of the 2021-2022 Officers

Dr. Rodrigo Romano, FAP Immediate Past President, announced the Executive Council nominated Dr. John W. Thousand, IV, for consideration as First Member at Large and asked for other nominations from the floor. Dr. Romano recited the FAP Investiture Oath and presented the 2021-2022 Florida Association of Periodontists Executive Council to the FAP membership


### Introduction of the 2021-2022 President

# Florida Board of Dentistry Report

The Florida Board of Dentistry (BOD) met via conference call on February 19, 2021. The in-person meeting was cancelled due to COVID, but the BOD still met to conduct business.

This was the first meeting with Dr. Nicholas White as Chair and the first meeting for new board members, Drs. Bojaxhi, Cherry, McCawley and Mellado, and Ms. Johnson.

Ms. Jessica Sapp, BOD Executive Director, gave an update on the dental therapy legislation and legislation that would allow the WREB exam to be accepted for licensure in the state. The BOD voted to oppose both issues.

At its November meeting, the BOD heard a revised proposal from the Council on Dental Hygiene to allow hygienists to use a laser while performing their remediable tasks, which died on a 4-4 vote. After this vote, the Florida Dental Hygienists Association requested the BOD revisit this rule and hold a workshop on the issue. No date has been set, but the BOD Chair indicated that it will be held the afternoon before the next time the BOD can meet in person, which most likely will be in May.

There were two informal hearings, four disciplinary cases, two determination of waivers and three voluntary relinquishments dealing with failing to meet the minimum standard of care and failing to keep adequate records.

The Anesthesia Committee Inspection reported there were 405 inspections in 2020 and to expect 600 in 2021. There are currently three inspectors, but two more will be hired for this year.

Mr. Fabio Andrade, Consumer Member, was elected vice chair for the next.
