

Description: The essentials for the safe and effective use of moderate sedation include medical evaluation, pharmacological principles, patient monitoring and team knowledge in recognition and management of sedation-related complications. These essentials will be reviewed, and their significance illustrated using case studies.

Morning Lecture:

Challenges in the Anterior Esthetic Zone: Implants, Teeth & Gingiva

Morning Session: Implants

Although advances in implant esthetic dentistry have been continuing to develop, complications still occur. Esthetic compromise including pink porcelain, prosthetic misfit, unesthetic restorations and patient dissatisfaction are a daily occurrence. The result of poor implant treatment planning can be mechanical failure and/or biologic failure ultimately resulting in financial failure. This course will review proper placement protocols and strategies for when ideal placement is not an option.

Educational Objectives:

- Discuss proper 3-dimensional implant placement.
- Discuss the compromise made when ideal placement is not an option.
- Discuss how to surgically replace compromised implants in the esthetic zone.

Afternoon Session: Teeth and Gingiva

Ideal outcomes in the anterior esthetic zone often requires tissue grafting to complement cosmetic restorative dentistry. Invasive grafting with traditional surgical techniques and materials can often lead to recession and esthetic defects. Advances in biomaterial and non-invasive surgery has given the clinician the ability to predictably augment deficiencies while not creating esthetic problems. This course has an aim to teach the participant atraumatic extraction, minimally invasive hard and soft tissue grafting, and review the latest biologic materials available.

Educational Objectives:

Learn techniques to carefully remove teeth. Learn the available non-invasive surgical hard and soft tissue techniques.

Discuss bio-promotive material available.

FAP Winter Meeting Recap

The 2022 FAP Winter Meeting was held February 11-12, 2022, at the Orlando Hilton.

On Friday afternoon, the 3rd year residents from the University of Florida and Nova Southeastern University participated in the 17th Annual Senior Residents Day. Before the presentations, the residents, along with faculty, and FAP leadership enjoyed a luncheon sponsored by the AAP and FAP. Dr. David Boden, President, Florida Dental Association (and FAP Member!), addressed the group. Afterwards, six residents presented on a variety of different topics. The day closed with the traditional FAP Welcome Reception.

Saturday morning kicked off with two corporate forums, Dr. Andrea Ravida, sponsored Lynch Biologics and Dr. Shaun Young, sponsored by Geistlich Biomaterials. Dr. Robert A. Levine, the featured speaker, spoke to dentists and dental team members on Predictable Evidence-Based Diagnostic and Surgical Procedures to Ensure Long-Term Clinical Success.

Below is a brief summary of the business meeting, with Dr. Walt Colón, FAP President, Presiding:

Dr. Colón welcomed everyone to the meeting. He introduced Dr. Ana B. Giglio, AAP Candidate for Secretary/Treasurer. Dr. Giglio addressed the group and stressed that she will continue to promote and work for the membership to give them the tools they need for practice success. She believes the AAP cultivates relationships, more so than any other specialty organization. Dr. James Wilson, AAP Immediate Past President, shared with the group that Dr. Giglio is running unopposed, but still wanted to attend this meeting and get to know the FAP members. He thanked Dr. Giglio for taking time to come to Florida and the FAP meeting.

Dr. Oscar Morejon, FAP Treasurer, reported the FAP Morgan Stanley Investment Account was up by 34% in the past 2.5 years. He said meeting sponsorship was good for the meeting and thanked Dr. Colón for his efforts in securing sponsors.

Dr. Colón reported the last SAP meeting was in North Carolina and the 2023 and 2024 SAP summer meetings will be in Florida. He announced FAP member, Dr. Cecil White, will be the SAP president in 2024.

Dr. David Boden, FDA President, provided an update on the Florida Dental Association's Dentists' Day on the Hill, which included information on the student loan repayment bill, which he hopes will be funded this year. He promoted FLA Mission of Mercy and encouraged everyone to volunteer for this event coming up in Tallahassee. He shared with everyone the FDA Team is there to help and their motto is, "Relentless Positive Action."

Dr. Susan LaMar, FAP Secretary, reported the last Florida Board of Dentistry meeting was November 19, 2021. At that time, there are 251 cases open and active. There were 565 dental sedation inspections in the past 15 months. She shared to view the upcoming agendas and minutes of past meetings, to go the BOD website.

Dr. Cecil White, AAP District III Trustee, provided the AAP report. The 2021 AAP Annual meeting this past November had 2,811 in attendance and much of the educational material is available at the AAP's E-Learning Center. The 2022 meeting will be in Phoenix, Arizona, October 27-30, and early bird registration ends April 9, 2022. The AAP recently completed

its fourth LEAD program. The dental hygienist engagement program is currently still in development. The AAP is instituting virtual district town hall meetings, May 11, 2022, will be the first one. More information will be sent soon on this.

Dr. Mark Abdoney, Perio PAC Chair, said the current balance is \$43,000. At this time, the only 25% of members have contributed. He said the PAC is functioning and is committed to preparing for the future.

Dr. Wagner Rodrigues Duarte, Graduate Program Director, UF, thanked the faculty and courtesy faculty. He introduced the UF residents. Dr. Saynur Vardar Sengul, Chair, Department of Periodontology, NSU, reported four residents graduated in 2021 and in July 2022, they will be bringing in four new residents. There will be a CODA site visit in May, and they are actively preparing for this. Two of the residents received scholarships to the Osteology Research Academy. The department received a grant to serve veterans and their families, the residents are honored to participate. The NSU Alumni event held in conjunction with the FAP meeting was wellattended and she wants this event to continue each year.

Dr. Michael Tesmer provided the FAP membership report. The FAP has a total of 294 members. He introduced the following members voted into membership by the EC: Drs. **Natalia Besada, Marela Garcia, Diana Bronstein, Hailey McKinley, Jason Wong**, and **Poliana Mendes Duarte Reis**. The EC also approved the following affidavits: Dr. Stuart Feldman (Life), Dr. Thomas Rubino (Life), Dr. Larry Shapiro (Life), Dr. Tyler Baldock (Retired), Dr. Ronald Kobernick (Retired) and Dr. Gary Perlman (Retired). Dr. Tesmer asked for a moment of silence in memory of Dr. Gilbert Bardfeld, Boca Raton, who passed away September 7, 2021.

Dr. Jessica Stilley Mallah, FAP Bylaws Committee Chair, thanked her committee for their dedication to this project. She reminded everyone the proposed bylaws revisions were noticed to membership November 2021. The revised bylaws were approved.

Dr. Jessica Stilley Mallah, FAP Immediate Past President, announced that the Executive Council nominated Dr. Todd Britten for consideration as First Member at Large and asked for other nominations from the floor. There were none. AAP Trustee Report

The AAP Board of Trustees met virtually on February 22, 2022. Below is a list of unofficial report of actions taken:

ORGANIZATIONAL VIABILITY

- Approved the proposed collaboration with the American College of Prosthodontics (ACP) and the American Association of Endodontists (AAE) on a joint meeting for 2024. Dr. Purnima Kumar will represent the AAP, in planning this collaborative meeting.
- Approved the proposed program and speakers for the 2022 Leadership, Engagement, Action, and Development (LEAD) Program.
- Appointed Dr. Wayne Aldredge as the AAP representative to the ADA National Commission on Recognition of Dental Specialties and Certifying Boards Appeal Board. He will serve a four-year term, from 2022-2026.
- Appointed Dr. Arif Salman Abdul Shakore as the AAP representative to the ADA Commission for Continuing Education Provider Recognition. He will serve a four-year term, from 2022-2026.
- Amended the 2022 Strategic Plan by adding the following language to Objective 2, Initiative 4: <u>Share survey findings with</u> members and educator community.
- The updated initiative would now read: "Dental Education: Share survey findings with members and educator community. Develop and deliver educator content."

EDUCATION

• Approved CEOC (Continuing Education Oversight Committee) oversight of the development, scheduling, and delivery of the AAP's webinar series for 2022-2023.

- Approved Dr. Mia Geisinger as speaker, for the AAP-sponsored session, at the 2022 American Dental Hygienists Association annual meeting.
- Approved the proposed additional speakers, moderators, and courses for the 2022 AAP Annual Meeting program.
- Approved Dr. Dimitris Tatakis as the AAP representative to fill the CODA Review Committee on Periodontics Education vacancy. The BOT also approved Drs. Panagiota Stathopoulou, and Vanchit John, in that order, as alternate AAP representatives to the CODA Review Committee on Periodontics Education vacancy.

MEMBERSHIP

• Approved the proposed AAP Connect Enhancement Plan and directed the Membership Sustainability and Growth Committee to work with staff to implement the Plan.

SCIENCE

• Approved adding Dr. Jennifer Chen as a review paper author for the Best Evidence Consensus on biologic mediators.

TOWN HALL MEETING

• The AAP is launching its first series of Town Hall Meetings this year. The first District 3 Town Hall Meeting is currently scheduled for Wednesday, May 11th, at 7:00 pm (EST). Further details on registration will be forthcoming.

Florida Board of Dentistry Report

The Florida Board of Dentistry (BOD) met in Gainesville, February 18, 2022.

Fourteen disciplinary cases were heard and acted upon. Total cases open/active as of today's date equal 200, with 54 cases being older than one year.

Rules report: Recent changes in language, minimum and/or maximum penalties for rules violations were summarized and are detailed in Board minutes, which can be accessed at the BOD website (i.e., floridasdentistry.gov). Definitions regarding nitrous oxide inhalation analgesia vs. sedation were clarified. Changes to remedial tasks delegable to the dental hygienist were proposed and adopted, and nitrous oxide inhalation analgesia may now be delivered under indirect supervision on an outpatient basis, barring some exceptions.

Bills currently under review by the Florida Legislature, which are of interest to organized dentistry, were summarized:

- SB 184 An act relating to dental therapy, creating the practice of dental therapy in Florida.
- HB 517 An act relating to dentistry and dental hygiene examinations.
- SB 926 An act relating to licensure examinations for dental practitioners.
- SB 466 An act relating to military-trained health care veterans.

The Anesthesia Committee proposed a rules change regarding the continuing education requirement for dentists holding an active sedation permit: "Each biennium, a 4-hour board-approved course in medical emergencies, to include a hands-on airway management component, must be completed."
