

Challenges in the Anterior Esthetic Zone: Implants, Teeth & Gingiva

Morning Session: Implants

Although advances in implant esthetic dentistry have been continuing to develop, complications still occur. Esthetic compromise including pink porcelain, prosthetic misfit, unesthetic restorations and patient dissatisfaction are a daily occurrence. The result of poor implant treatment planning can be mechanical failure and/or biologic failure ultimately resulting in financial failure. This course will review proper placement protocols and strategies for when ideal placement is not an option.

Educational Objectives:

- Discuss proper 3-dimensional implant placement.
- Discuss the compromise made when ideal placement is not an option.
- Discuss how to surgically replace compromised implants in the esthetic zone.

Afternoon Session: Teeth and Gingiva

Ideal outcomes in the anterior esthetic zone often requires tissue grafting to complement cosmetic restorative dentistry. Invasive grafting with traditional surgical techniques and materials can often lead to recession and esthetic defects. Advances in biomaterial and non-invasive surgery has given the clinician the ability to predictably augment deficiencies while not creating esthetic problems. This course has an aim to teach the participant atraumatic extraction, minimally invasive hard and soft tissue grafting, and review the latest biologic materials available.

Educational Objectives:

- Learn techniques to carefully remove teeth.
- Learn the available non-invasive surgical hard and soft tissue techniques.
- Discuss bio-promotive material available.

AAP District III Trustee Report

The Board of Trustees met May 6-7, 2022, in Austin, Texas. The following is a summary of actions.

ORGANIZATIONAL VIABILITY - Approved the 2023 Strategic Plan. Highlights include activities to enhance member value, a multi-year science strategy, and pursuit of Academy revenue diversification. The Board also approved revisions to the Administration, Governance, and Membership sections of the AAP Policy Manual. Additionally, the Workgroup to Review Governance, Constitution and Bylaws was directed to draft two amendments to the Awards section of the policy manual providing direction on how the Board selects award recipients.

AAP staff were charged to negotiate a favorable lease renewal of 737 North Michigan Avenue, Suite 800, Chicago, Illinois, 60611, to optimize cost savings and tenant benefits.

<u>LEADERSHIP</u> - Approved the selection of awardees for the 2022 Gold Medal, Master Clinician, Distinguished Scientist, Distinguished Service, Honorary Membership, and H. Dalton Conner Humanitarian awards. In addition, the Board approved a nominee for the ADA Norton M. Ross Award for Excellence in Clinical Research and ranked finalists of the ADEA William J. Gies Award. Proposed appointments to the 2022-2023 In-Service Examination Committee were also approved.

EDUCATION - Approved additional speakers, moderators, and courses for the 2022 Annual Meeting Program as well as the proposed 2023 Annual Meeting CE Program. Speakers and topics for Specialty Speaker Spotlight at the ADA's 2022 Annual Meeting were approved as were the speakers and topics proposed by the Academy for the 2023 International Osteology Symposium (IOS) in Barcelona, Spain.

MEMBERSHIP - Approved the Membership Value Enhancement Plan as proposed by the Membership Sustainability and Growth Committee (MSGC). The plan includes strategies to better communicate with members and provide a more robust member value proposition.

<u>SCIENCE</u> - Approved the Task Force on Future Science's proposed scientific strategic plan. The multi-year approach identified priority areas such as peri-implantitis, the periosystemic link, and diagnostic technologies.

2022 ANNUAL MEETING - The meeting will be fully live and in-person taking place October 27-30 in Phoenix. Members can review the program, register, and secure housing at https://am2022.perio.org/

<u>AAP ELECTIONS</u> - Active and Life Active members can vote in the 2022 election beginning June 1. Ballots will be distributed to all eligible voting members by June 1, and voting may be done electronically or by mail. Questions about the election? Contact amanda@perio.org.

ISPRD 2022 AND EUROPERIO10 - The AAP will return to Quintessence Publishing's International Symposium of Periodontics & Restorative Dentistry (ISPRD), June 9-12 in Boston. AAP staff will be on hand promoting membership and administering continuing education. In addition, the AAP will have a booth at the upcoming EuroPerio10 meeting, June 15-18 in Copenhagen, Denmark.

Florida Board of Dentistry Report

The Florida Board of Dentistry (BOD) met in Jacksonville on Friday, May 20, 2022. Dr. Susan LaMar, FAP President Elect, and Dr. John W. Thousand, IV, FAP Second Member-at-Large, attended the meeting.

The board approved removing language from the rules on the dental and dental hygiene licensure exam regarding assessing people for suitability as exam patients since Florida now accepts the non-patient-based exam. It also approved language for a new rule regarding unexcused absences from board meetings as the board did not have a rule for this previously.

In November 2021, the board unanimously approved language allowing a hygienist, with appropriate training, to administer nitrous oxide to American Society of Anesthesiologists (ASA) I-III patients under indirect supervision. Language was also approved that stated a hygienist, with appropriate training, can only administer nitrous oxide to ASA IV, special needs and previously sedated patients under direct supervision. This rule has been moving through the administrative process. The Joint Administrative Procedures Committee (JAPC) – a committee

of the Florida Legislature that reviews all rules to ensure they do not exceed statutory authority – had some questions about the safety of the administration of nitrous oxide. Ultimately, under guidance from the BOD attorney, the board approved amended language as to satisfy JAPC while still achieving the goal of the rule language passed last November. The proposed language changes the word "administer" to "assist the dentist in the initiation of nitrous oxide."

The BOD Anesthesia Committee will be meeting in June and August (conference call) to discuss the amounts of various drugs and required equipment sedation permit holders must have in their dental office. The current rules have led to some confusion and has resulted in different inspectors requiring dentists to have different amounts upon inspection. Recent training was held with all dental inspectors to educate them about the rules in an attempt to standardize inspection procedures.


